AGREEMENT FOR ACCOUNT WITH PUMPER'S PREMIUM STORES INC.

1. All payments due upon receipt. Statements will be mailed twice per month. Payments are due within 10 days from date of invoice.
2. A service charge of 1-1/2% per month will be charged on all past due balances.
3. In the event of non payment and institution of legal proceedings the person, firm or corporation to whom credit was extended agrees to bear the expense of all legal proceedings plus a reasonable attorney's fee.
4. Advance written notice must be given to Pumper's Premium Stores, Inc. of any changes in the business structure relating to incorporation or change of ownership. Without such notice, the individuals or principals to whom credit was extended shall remain liable for the indebtedness.
5. Pumper's Premium Stores, Inc. reserves the right to withhold delivery to customers whose credit accounts are past due.
6. Pumper's Premium Stores, Inc. Automatic fleet card is the property of Pumper's Premium Stores, Inc. and must be surrendered upon demand.
7. Pumper's Premium Stores, Inc. may change any of the terms of this agreement by notice mailed to me not less than 15 days prior to the billing cycle in which the change is effective. Any credit purchase by me after the change will be my agreement that the new terms apply to my previous balances and future purchases. If I do not agree I will give notice to Pumper's Premium Stores, Inc. enclosing my Pumper's Premium Stores Incorporated Automatic Fleet Fueling card. And pay odd my outstanding balance according to the terms in effect prior to the change.
8. In consideration of the credit extended by Pumper's Premium Stores, Inc. I agree to be responsible and to pay for all purchases made by the use of or with the use of the Pumper's Premium Stores, Inc. Automated Fleet Fueling Card.  
  
Liability I limited as follow: If I misplace, lose, cannot account for, have stolen or am worried someone might use one or more of the cards to make unauthorized purchases, then I will by telephone, writing, notify Pumper's Premium Stores, Inc. at PO box 2965, Easley, SC 29641-2965. Telephone at 864-306-2999.  
  
Once the card is invalidated, I will be protected from further liability of unauthorized purchases. It is agreed and understood that I am liable for all purchases up to and including the time Pumper's Premium Stores, Inc. is notified of my request to invalidate a certain card or cards. This liability exists and is accepted no matter who makes the purchases and whether or not the purchases were authorized.
9. No receipts will be mailed with the Pumper's Premium Stores automated Fueling System invoice, but signed receipts will be issued at time of purchase.
10. A \$7.50 per card fee will be charged for any lost, stolen, or misplaced Pumper's Premium Stores, Inc. fueling card.
